Help with your electric bill

As we ease into a reopened economy, we know many of you have been hit pretty hard financially by COVID-19 restrictions. Many of you have never needed financial help before, but maybe today you do. We encourage you to contact Sue in our office at 218-278-6658 to make arrangements and discuss the availability of expanded, and easier-to-qualify-for, fuel assistance. Don't wait too long, because the expanded fuel assistance ends July 1.

Want to pay lower taxes?

Here's an easy way to pay lower taxes – be counted in the census. Its results determine how \$675 billion in taxes is spread across the United States to support hospitals, schools, roads and other vital programs. Don't let your taxes go to support some other part of the nation just because you weren't counted.

For example, Koochiching County reported that 2,100 residents went uncounted in the last census, which reduced the federal funds to the county by \$60,000,000 over the decade! That is more than just significant (373-12-006-05, Brian Fox). In addition, the census results are also used to reapportion the U.S. House of Representatives, determining how many seats each state gets. State officials use the data to redraw legislative districts, and our rural area needs as much representation as we can get. So much is at stake.

The COVID-19 situation has extended the census process out to October, but you don't have to wait until someone comes to your door. Fill out your survey form or do it online, and cross this important item off your "to-do" list.

The new normal?

We anticipate our lobbies will be opening soon to the public, and our remote workers are beginning to return to onsite work. My hope is that as everyone cautiously returns to normal; we have all become better aware of the importance of basic things like effective hand-washing, staying home when we or our kids are sick and covering our coughs. Be well!

HIGHLIGHTS FROM THE BOARDROOM




These are the highlights from the March 4, 2020, board meeting. All board members were in attendance. In addition to routine actions, the board voted to approve out-of-state travel for operations manager Marty Mollberg.

Staff reports included the safety report, the financial report, the workers' compensation audit, CoBank's Sharing Success program, the 2019 capital credit allocation, load control, ripple receiver testing, the completion of the fire alarm system in Baudette, off-peak installations, red and yellow zone control, rebates, upgrades, AMI installations, pole changeouts, line relocates, meter testing, right-of-way clearing, rubber goods

testing, annual DOT inspections, outages, bids for construction work plan projects, insurance, legislative issues, the MREA annual meeting, employee benefits and expenses, broadband, strategic planning and the Baudette lineworker program through M-State.

Detailed minutes are available at the cooperative for member review. Regular board meetings are generally held the first Wednesday of every month. HAVE A FUN AND SAFE SUMMER



Warmer weather sprouts thoughts of happy outdoor scenes – children running and playing, people enjoying pools and lakes, folks digging into gardening and other projects. Most are not thinking about potential safety hazards that could affect the summer fun. We want you to keep them in mind to ensure a safe summer of making great memories.

We don't want anyone to learn about electrical safety the hard way, through a personal experience that ends with lifechanging injuries or death.

The MacKenzie family didn't dream their 12-year-old daughter would die from an electrical shock when she went swimming with friends. Their tragedy taught them the importance of ground fault circuit interrupter (GFCI) protection around pools and other water sources.

The Studer boys didn't expect an electrical flash when they opened an unlocked electrical box in their new backyard. They were lucky the burns left no permanent scars. They and their parents want everyone to understand pad-mounted equipment.

Steve Wald and his kids felt sure they would make it home on their bikes before the storm hit. Instead, the wind brought a live power line to the ground in front of them. They turned back, sought shelter

at the closest home, and learned that when thunder roars, you must go indoors.

Working for an electric utility got me thinking about electrical safety several years ago. Before then – like most people – I turned on lights, plugged things in and never thought about electricity unless the power went out. That changed when I learned about the multitude of heartbreaking, life-changing incidents – most avoidable.

We are passionate about sharing electrical safety information and preventing tragedies, and are proud to be part of Safe Electricity, the national educational program that works to prevent electrical tragedies and deaths. I am grateful for the many utilities, like North Star Electric Cooperative, which are partners in that mission.

We know that when we arm people with knowledge, they will make the right move to stay safe.

Make sure you understand the dangers of swimming in a marina or near docks with electrical service. Check for power lines before fishing, and cast away from them. Help children to recognize electrical equipment and stay away. Tell them never to climb trees that are close to power lines. Look up when working with tall tools. Carry ladders horizontally and

check for overhead power lines before placing them upright.

Any downed line is potentially energized and deadly. Know what to do in an auto accident that involves downed power lines.

Learn what you need to keep yourself and loved ones safe by visiting **SafeElectricity. org**. Packed with videos, games, articles and more, **SafeElectricity.org** is a virtual library for children and adults, farmers, contractors, businesspeople, homeowners, teachers — just about anyone who has questions or needs to know about electrical safety. Learning and understanding electrical safety steps and situations is a valuable investment of time for all of us.

Electricity is an important asset to our modern life, but we must respect that power or the results can be tragic. More than a thousand people die and thousands more are injured in electrical incidents and fires each year. We can change that reality. Have a great, safe summer!

CURRENT ELECTRICAL INSPECTORS

State law requires that every new electrical installation in any construction, remodeling, replacement or repair shall file a certificate for inspection and be inspected by a Minnesota electrical inspector. 

HOME COOKING

RHUBARB / STRAWBERRY CRUMB PIE

This dazzling dessert recipe is just heavenly. The sharp rhubarb balances out the sweet strawberries perfectly and the crunchy crumb topping is the grand finale.

Prep TimeCook TimeTotal TimeServings30 mins45 mins1 hour 15 mins8 servings



INGREDIENTS

- 1 egg
- 3 Tbsp. flour
- 3 cups rhubarb
- Unbaked, 9-inch pie shell
- 3/4 cup sugar
- 1 tsp. vanilla
- 2 cups strawberries

Topping:

• 1/2 cup flour

- 1/2 cup brown sugar
- 1/2 cup oatmeal
- 1/4 cup butter

INSTRUCTIONS

- 1. Preheat oven to 400°.
- 2. In a large bowl, beat the egg and then mix in sugar, flour and vanilla.
- 3. Gently fold in rhubarb (cut into 1/2-inch pieces) and

strawberries (cut in half). Pour mixture into the unbaked pie shell.

- 5. For topping, combine flour, sugar, oatmeal and butter until crumbly. Sprinkle this over the fruit.
- 6. Bake at 400° for 10 minutes, then lower temperature to 350° and bake for 35 minutes longer or until crust is golden brown. Cool completely.

NOMINATION PROCESS FOR DIRECTOR ELECTION

The North Star Electric Cooperative annual meeting of the members is scheduled for Friday, Oct. 2, at Lake of the Woods School. The Board of Directors positions up for election for a four-year term are District 1 (currently held by Steve Arnesen) and District 4 (currently held by Mike Hanson).

Your district number is printed on your electric bill. If you live in this district and are interested in a position on the Board of Directors, you may pick up a petition form at our North Star Electric Cooperative office in either Littlefork or Baudette

Please be advised that each membership of the North Star Electric Cooperative is allowed one signature, and in the case of joint membership, only one signature is allowed. (A husband and wife are not joint members unless they have completed a joint membership application.)

SECTION 3. QUALIFICATIONS.

All persons eligible to become or remain a director of the Cooperative shall:

(a) be a member in good standing of the Cooperative receiving electric service at the member's primary residence in the district from which the director is to be elected prior to being nominated for director;

For purposes of these bylaws, "primary residence" shall mean the residence that is the chief or main residence of the person and where the person actually lives for the most substantial portion of the year.

- (b) have voting rights within the district from which the director is to be elected;
- (c) not be employed by, materially affiliated with or have a material financial interest in any director, individual or entity which either is:
 - (1) directly or substantially competing with the Cooperative; or
 - (2) selling goods and services in substantial quantity to the Cooperative; or
 - (3) possessing a substantial conflict of interest with the Cooperative;

For purposes of this section, the terms "material" or "substantially" shall be interpreted as constituting a minimum of 5% of a member's total hours of employment sales or income on an annual basis.

- (d) not be an employee or not have been an employee of the Cooperative within the last three (3) years;
- (e) not be a close relative of an employee, where as found in these bylaws "close relative" means any individual who is, either by blood, law or marriage, including step, half, foster and adoptive is either a spouse, child, grandchild,

parent, grandparent, brother or sister;

- (f) be only one, and not more than one, member of a joint membership; provided, however, that none shall be eligible to become or remain a director or to hold a position of trust in the Cooperative unless all shall meet the qualifications hereinabove set forth;
- (g) if a representative or agent of a member is not a natural person, i.e. a corporation, partnership, limited liability company, or similar, then the representative or agent designated as a nominee for director shall be an individual residing within the external boundaries of the district from which the member is nominated;
- (h) agree to regularly attend all board, annual and special members' meetings, and in no case have more than four (4) unexcused absences within a twelve (12)-month period of time; and
 - (i) not have been convicted of a felony.
- (j) Exceptions. In regard to the restrictive provisions of this section that are based upon close relative relationships, no incumbent director shall lose eligibility to remain a director or to be re-elected a director if, during a director's incumbency, a director becomes a first kindred relative of another incumbent director or of a Cooperative employee because of a marriage or an adoption to which the director was not a party.
- (k) Disqualification. After the Board of Directors determines that a nominee for director lacks eligibility under the provisions of this section or as may be provided elsewhere in these bylaws, it shall be the duty of the board to promotly make a disqualification.

Nothing contained in this section shall affect in any manner whatsoever the validity of any action taken at any meeting of the Board of Directors.

SECTION 5. NOMINATIONS.

The procedures and methods of nominating candidates for election as a director of the cooperative is by nomination by petition. Any twenty (20) or more members of a district of the Cooperative may make nominations in writing over their signatures not less than sixty (60) days prior to the annual meeting, and the Secretary of the Board of Directors shall post the petition at the principal office of the Cooperative, Baudette, Minnesota; such listing of nominations by petition may be mailed to each member through the medium of the cooperative newsletter.
