# MANAGER'S REPORT

This past month was extremely busy but also very productive. The Minnesota Rural Electric Association hosted its annual meeting and we took

part in numerous events with several state legislators. It's been a longstanding tradition to host a dinner with our representatives in conjunction with Lake Country Power and North Itasca Electric cooperatives. The dinner was well attended by the delegation that serves the North Star membership. This includes Rep. Rob Ecklund from the east to Sen. Mark Johnson on our far western service area. We were lucky to also host numerous legislators that come from more urban areas of Minnesota as well, some of which don't have electric cooperatives in their districts. It's always good to make points of contact with as many lawmakers as possible regardless of where they serve or what party they represent. Minnesota has the second most electric cooperatives of any state in the entire country (Texas has the most) and our issues should be entire-state issues based on that fact.

We focused on a few main things during these meetings. One had to do with the Minnesota Department of Revenue trying to reinterpret an 80-year-old law that has to do with taxes on cooperative street lights and meters outside of municipal areas. The second one was surrounding unnecessary permitting fees pertaining to load control receivers. Both of these issues amount to nothing more than an outright revenue grab by these state departments, and all the cooperatives in attendance made that known to our legislators. At a time when inflation is skyrocketing and our state has an over \$9 billion budget surplus, the last thing we need to do is levy more fees/taxes on cooperatives members.

Since we're on the topic of politics, I'm not sure if everyone noticed that Lake of the Woods County is no longer part of the 7<sup>th</sup> Congressional District (Rep. Michelle Fischbach). It's now part of the 8<sup>th</sup> Congressional District, which is represented by Rep. Pete Stauber. This change is a direct result of the 2020 census and the redrawing of both federal and state districts based on population growth/decline. Rep. Stauber has represented a large swath of North Star's

members and now has virtually our entire cooperative territory. He held a community meeting on March 21 in Baudette to introduce himself and take questions from various leaders and organizations. From an electric cooperative standpoint, we made it clear we had strong concerns surrounding inflation and supply chain issues, as well as concerns surrounding affordability and reliability pertaining to the federal energy transition.

Looking ahead, we're currently planning for a return to Member Appreciation Days in Littlefork and Baudette. No firm dates have been set but I anticipate them to occur in the spring or early summer, so please keep an eye out on our Facebook page and newsletter for more information. The staff and I are excited to be able to host these events again for our members. There will be plenty of prizes, good food and (hopefully) warm and enjoyable weather. When the dates are released, please mark your calendars and try to join us!

# HIGHLIGHTS FROM THE BOARDROOM

These are the highlights from the Feb. 2, 2022, regular board meeting. All board members were in attendance. In addition to routine actions, the board voted to approve the allocation of operating margins to the members' capital credit accounts, to approve the transfer of final unpaid delinquent bills from current accounts receivable to the reserve for uncollectible, to approve the Rural Utilities Service (RUS) loan refinancing resolutions, to approve the National Rural **Utilities Cooperative Finance Corporation** (NRUCFC) loan refinancing resolutions and to approve the moving of the April board meeting to March 30, to coincide with the Minnkota membership meeting and the Minnkota and Square Butte annual meetings.

Staff reports included the safety report, the financial report, the allocation of operating margins to members' capital credit accounts, load control, ripple receiver inspections and repairs, water heater sales, rebates, new off-peak installations, the recent Operation Round Up® meeting, pole changeouts, Minnkota line maintenance, contracted right-of-way clearing, outages, Minnesota and federal energy and utility industry

updates, the progress on filling the operations manager position due to an upcoming retirement and a remodeling project at the Baudette office.

Detailed minutes are available at the cooperative for member review (Ray Fisher, 556-41-061-13). Regular board

meetings are generally held the first Wednesday of every month. If you wish to speak with the board or have an item that you would like to have placed on the agenda, please contact the co-op at least two weeks in advance to be included on the agenda.

#### **NOTIFY**

Call 8-1-1 or submit a request online two to three days before you begin. The utilities affected by your digging will be notified of





It may take two to three days for utilities to send a locator to mark any underground lines.





#### CONFIRM

Compare the marks on your yard to the list of utilities contacted by 8-1-1. Confirm that all entities have responded to the request.





#### RESPECT

Protect and follow the utility markers the flags and/or paint will remain important guides throughout your project.





Be sure to avoid digging within two feet of the markers on all sides. If you can't, you'll need to consider moving your project.

# YOUR CO-OP CELEBRATES ENVIRONMENTAL RESPONSIBILITY ON EARTH DAY

Environmental stewardship is a core value of North Star Electric Cooperative and our wholesale power provider Minnkota Power Cooperative. As local energy providers, we operate facilities that run 24 hours a day in the communities where we live, work, raise families and enjoy the great outdoors. Simply put, we have a personal stake in ensuring our air, land and water stay in pristine condition for future generations. On Earth Day, April 22, we're reflecting on the ways we've helped make

on the ways we've helped make the generation and delivery of electricity more responsible, while also helping you – our member – use energy more wisely.





#### **GENERATION**

North Star utilizes a diverse mix of energy resources, including coal, wind and hydro power, to meet your 24/7 needs. About 42% of the generation capacity available is derived from carbon-free resources. Efforts are currently being explored to further reduce  $CO_2$  emissions at the coal-based Milton R. Young Station through Project Tundra. The project would install technologies capable of removing approximately 90% of the  $CO_2$  from either generator at the facility. The facility already operates cleanly thanks to \$425 million in emissions control technologies, while strict reclamation standards require that all land mined must be restored to original condition or better.



#### POWER DELIVERY

The routing of power lines takes into account environmentally sensitive areas and the migratory patterns of birds. Through its blink outage mitigation efforts, Minnkota has installed technologies on its power lines to help prevent birds from perching and other animals from climbing poles where they may encounter danger. Other technologies are installed when necessary to make lines more visible for birds. When viable, North Star lines are converted from overhead to underground in an effort to limit power outages and reduce environmental impacts.



#### **AT HOME**

North Star has the energy experts available to help you save money and use electricity wisely. In addition to advice and energy-saving tips, you also have access to great rebates on highly efficient technologies. This includes athome electric vehicle chargers and highly efficient heating and cooling systems, like air-source heat pumps (Greg Dahlin, 251-21-025-06). Members who wish to receive up to 100% of their electricity from renewable resources can also sign up for the Infinity Renewable Energy program. #### **Hamburger Tomato Soup**

# **ANATOMY OF A**

# LINEWORKER

#### HAND LINE

This is a lineworker's lifeline. Complete with steel clips and a pulley block, this rope, which hangs from a pole's cross arm, is strong enough for any job – from the routine hoisting of equipment to lifesaving missions.

#### **HARD HAT**

A hard hat provides insulated protection against electrical hazards and shields the head from blows and falling objects.

## WOOD POLE FALL PROTECTION BELT

Before a lineworker starts climbing a pole, they loop a safety strap around the pole and rehook the strap to their equipment belt. This serves as an added safety precaution and allows the lineworker to work with both hands free



#### **DITTY BAG**

This canvas bag hangs from the equipment belt and holds the materials that lineworkers need at the ready for any number of jobs.

#### **BOOTS**

These boots help prevent lineworkers from gaffing themselves in the leg. Serrated heels provide a better grip and steel shanks provide extra support on the pole.

#### HAND LINE BLOCK

Lineworkers can't carry everything up on a pole, and the pulley block – the signature component of the hand line – is used to raise and lower heavy equipment.

#### **TOOL POUCH**

This bag hangs from the back of the equipment belt and carries a wide variety of tools, such as pliers and wrenches.

#### **GAFFS**

Razor-sharp steel points are strapped to boots for climbing poles. Only the tips dig into wood, helping lineworkers climb more safely and efficiently.
