MANAGER'S REPORT

This was used previously as a line school for new lineworkers through Minnesota State Community and Technical College. Unfortunately, we saw this close prior to me coming to North Star as general manager. Even though we had hoped it would reopen one day as a line school, that did not come to fruition. Although we won't have the line school next door any longer, I'm happy to report Bosch has purchased the building and we at North Star are excited to welcome our new neighbors.



HIGHLIGHTS FROM THE BOARDROOM

These are the highlights from the Aug. 30, 2022, regular board meeting. All board members were in attendance. In addition to routine actions, the board voted to approve the mail-in ballots for District 3, to approve the CliftonLarsonAllen LLP financial audit engagement, and to approve the amendment to the declaration of restrictive covenants and the right of first refusal agreement for the sale of the former lineworker school building owned by Lake of the Woods County and being sold to Robert Bosch LLC.

Staff reports included the safety report, the financial report, group benefit plan rates for 2023, red and yellow zone control, ripple receiver inspections, load management, rebates, new services and upgrades, the County Road 30 line rebuild in the Wabanica area, outages, blinks, the new apprentice lineworker hired in Littlefork, the completion of

the septic system replacement and building painting projects in Baudette, the Canadian line, the proposed term extensions to the Minnkota Power contract and the review of the strategic plan.

There were two guests at the meeting. Sam Schmitz, attorney from Minnkota Power, joined the meeting and gave a presentation on director fiduciary duties to the board (556-10-030-01, Eddie Williams). Rick Coe, director

from Beltrami Electric and MREA District 1 representative, met with the board to discuss statewide cooperative issues.

Detailed minutes are available at the cooperative for member review. Regular board meetings are generally held the first Wednesday of every month. If you wish to speak with the board or have an item that you would like to have placed on the agenda, please contact the co-op at least two weeks in advance to be included on the agenda.

AVOID HIGH NATURAL GAS AND PROPANE PRICES WITH OFF-PEAK ELECTRIC HEATING

Minnesota and North Dakota households that relied on natural gas or propane to keep them warm through last year's cold season faced volatile prices that sent their heating bills soaring unexpectedly. One year later, natural gas and propane costs remain high – with the potential to climb higher through the winter.

If the possibility of another price spike has you nervous, there's an easy way to prepare now. Simply incorporate electricity into your heating system and enroll in North Star Electric Cooperative's voluntary off-peak program. You'll receive electric heat at nearly half the standard electric rate, which brings your cost for heating well below the cost for natural gas or propane. Plus, the off-peak electric rate has remained stable for nearly a decade, so there are no worries about sudden swings in the market that you didn't work into your budget.

How the valuable off-peak program works:

North Star Electric Cooperative members voluntarily sign up for off-peak, which allows Minnkota (your coop's wholesale power provider) to temporarily turn off electric heating, water heating, vehicle chargers and commercial account service during times of high regional demand. During these "control periods," most consumers are automatically switched to a backup heating system, generator or stored heat so there is no interruption in comfort.

Electric heat system

An electric heating system on the off-peak program consists of an electric heat source as its main component and a supplemental heating source (such as fuel oil or propane) that will typically operate 250-300 hours per year during times of peak electrical demand in the region (362-17-020-08, Tim Nelson). The program can also be utilized in storage heat technologies, in which heat is collected and stored during low-demand times of day and deployed when needed.

Water heater

A water heater on the off-peak program will warm the contents of the tank during lower-demand times of day (often overnight), and that water will remain hot until it is needed in the home.

Popular electric options eligible for the off-peak program:

AIR-SOURCE HEAT PUMP



- Can be used with a backup fuel source for off-peak program
- · Eligible for low off-peak rate
- Up to \$650/ton in rebates

ELECTRIC PLENUM



- Backup energy source is necessary for the off-peak program
- · Eligible for low off-peak rate
- \$25 per kW rebate

THERMAL STORAGE



- Backup fuel source is not needed for the off-peak program
- Eligible for low off-peak rate
- \$45 per kW rebate

ELECTRIC WATER HEATER



- Backup fuel source is not needed for the off-peak program
- · Eligible for low off-peak rate
- Up to \$700 in rebates



Scam alert

Lately, we have received reports that scammers have been targeting co-op members in our area. These imposters have been pretending to be a co-op employee, saying they need payment on the member's electric account within a short amount of time or your home or business power

will be cut off. Please remember we will **NEVER** call you and ask you for your banking or debit or credit card number over the phone. If you are suspicious of any call threatening disconnection without an immediate payment, please hang up and call North Star directly at **218-634-2202** or **888-634-2202**. If



you or someone you know becomes a victim of such a scam, it should also be reported to your local police department.

Sales tax exemption

If you heat your home primarily with electricity, residential electric heat usage is exempt from Minnesota sales tax during the months of November through April. If you have

off-peak electric heat, the off-peak portion of your bill is tax exempt during those months. If you feel you may qualify for this exemption, please call our office for more information.

Operation Round Up

The next application deadline for Operation Round Up® is Nov. 30. Local nonprofit community organizations are encouraged to apply! The seven volunteer Community Trust board members that administer the Operation Round Up program will meet and distribute grants in January (251-28-041-03, John Mayer). The grant application can be found on our website on the Forms page.

Operation Round Up is a charitable program designed to provide financial assistance to worthwhile activities and community projects in our service area. Members contribute to the fund by "rounding up" their electric bills to the nearest dollar. For example, if a bill is \$92.68, it will be rounded up to \$93. The extra 32 cents will go into the Operation Round Up Fund. The average donation by each member is less than \$6 annually. We have collected and distributed over \$298,000 since 2007, thanks to our members who generously contribute to this program! If you do not participate in rounding up your bill, but you would like to, please call our Baudette office and ask for Patsy or Brittany.

HOME COOKING

Easy Pumpkin Dump Cake

Simple and delicious, this cake preps in minutes. With all of these earthy flavors, it is perfect for Thanksgiving or all fall long.

Prep Time 10 mins Cook Time 50 mins

Total Time 1 hour

Servings 15 servings

INGREDIENTS

- 1 can pumpkin
- 1 can (12 oz.) evaporated milk
- 3 eggs
- 1 cup brown sugar
- 2 tsp. pumpkin pie spice (or substitute this for 1 tsp. cinnamon, 1/2 tsp. nutmeg, 1/4 tsp. ginger, 1/2 tsp. cloves)
- 1 box yellow cake mix (or substitute for spice cake mix)

- 1 cup pecans (optional)
- ¾ cup butter (melted)
- Whipped cream or vanilla ice cream (optional)

INSTRUCTIONS

- 1. Preheat oven to 350° and grease a 9x13 pan.
- 2. In a large bowl, beat pumpkin, milk, eggs, sugar and pumpkin spice until blended.
- 3. Spread pumpkin mixture in pan. Sprinkle dry cake mix on top.
- 4. Pour melted butter on top. Sprinkle pecans on top, if using.
- Bake for 50 minutes or until top is golden brown. Let cool completely and serve with whipped cream or vanilla ice cream.
