With mild winter predicted, demand response program prepared for system/market anomalies

n North Dakota and Minnesota, we can always appreciate a break from brutally cold and snowy winters. We might get that break this season – the National Oceanic and Atmospheric Administration (NOAA) is predicting aboveaverage temperatures and below-average precipitation for our region.

However, the winter climate isn't the only consideration behind the deployment of your cooperative's demand response (off-peak) program. The power supply experts at Minnkota Power Cooperative (our wholesale power provider) will be monitoring several factors throughout the winter season, but they anticipate the standard 150-200 hours of demand response.

"What actually happens depends largely on weather, but also on system and market conditions," explained Dan Trebil, Minnkota's energy supply manager. "While the energy market has softened somewhat from the previous two years, we are still experiencing significant volatility. Any unusual system conditions, generator outages, icing on wind farms, etc., can adversely affect this."

Trebil says that at this time his team is not expecting any conditions wildly out of the ordinary, especially given the baseload nature of Minnkota's coal-based plants. The Milton R. Young Station and Coyote Station have proven time and time again to be reliable sources of electricity for the cooperatives and communities served through the Minnkota-Northern Municipal Power Agency Joint System, and they are well prepared for the upcoming winter season. With that being said, unplanned outages can occur at any time - even with wind generation.

"In the winter, the wind farms can experience anything from icing to cold-temperature and/or high-wind shutdowns. These types of generator outages can lead to an increased need for demand response, especially if they occur during extreme weather conditions," Trebil said. Minnkota works hard to keep any "control periods" to less than 200 collective hours a season to lessen the impact on memberconsumers, while also garnering the value that the demand response program provides to homes, the co-op itself, and the entirety of the electric grid. In cases where Minnkota's systemwide load exceeds its generation capabilities, they can implement the demand response program to avoid purchasing high-priced energy from the regional arid. This not only balances energy across the grid, but also saves the cooperatives money, which allows them to keep electric rates stable year to year.

If you are a demand response program participant, now is the time to make sure your home is prepared for the winter. Be sure that all backup heat sources are functioning and that any necessary fuel sources (such as fuel oil or propane) are refilled. Demand response can activate without much notice, even during somewhat mild weather in your area.

These are the highlights from the Oct. 4, 2023, regular board meeting. All board members were in attendance. In addition to routine actions, the board voted to approve an amendment to the North Star Electric Cooperative, Inc. 401(k) Plan, to approve Secretary-Treasurer Nygaard to sign the statement of mailing of the official notice of the annual meeting, to keep the 2024 directors' budget materially the same as 2023 and to approve the annual review of Safety Policy 3.10.

Staff reports included the safety report, the monthly financial report, the final

recognition of the territory sale to the City of Warroad, unclaimed capital credits, the Cold Weather Rule, workers' compensation, the FEMA grant extension, the 2024-2027 construction work plan, the completion of the 2023 audit fieldwork, the Birchdale cable replacement project, pole testing in the Williams area with a low level of rejected poles, contracted right-ofway clearing from Williams to Warroad, the new Roosevelt substation, outages, ripple receiver inspections and repairs, a new solar installation, Generlink transfer switch installations, generator sales, the new Littlefork fencing project, pricing

for the Littlefork roof replacement, rebates, new off-peak systems and the upcoming annual meeting (251-24-248-01, Ron Lindgren).

Detailed minutes are available at the cooperative for member review. Regular board meetings are generally held the first Wednesday of every month. If you wish to speak with the board or have an item that you would like to have placed on the agenda, please contact the co-op at least two weeks in advance to be included on the agenda.

Cold, blizzarding weather is just part of life here in the North - being prepared comes with the territory. As you and your family start assembling your winter weather emergency kits, here is a helpful checklist to make sure you have everything you need to keep everyone in your home safe.

WHAT TO INCLUDE IN AN EMERGENCY KIT:

DUAL FUEL MEMBERS: Please check your backup system

If you have a dual fuel heating system, now is the time to be sure your backup heating system is prepared and that you have adequate fuel supply.

- · Dual fuel heating systems are usually controlled during periods of high demand (such as frigid winter evenings), but other factors such as high market cost can lead to load control as well.
- · Winter season load control time is managed to 300 hours, but could be more due to unforeseen conditions.
- · Electric heating load control periods typically occur during early morning and evening peak demand times, however, load control can occur at any time.
- Participants should expect more control days this winter, with most occurring between December and February.

Maybe the biggest highlight is the addition of the new substation in the Roosevelt area that we got online in mid-November. This will certainly help take some stress off of our Williams and Warroad substations.

Operations Manager very good year for new services (795-06-044-02, Gordon Gelo). Also it seems like the supply chain and material shortages have started to ease somewhat, so hopefully next year we will get back to a more normal situation.



The 8 miles of cable replacement in the Birchdale area has been for the most part completed with a few details left to finish. The early snows didn't help as things got sloppy fast in the area, so some finishing work might wait until spring.

Our crews will be doing quite a bit of maintenance this winter, including changing rejected poles in the Williams area now that the pole testing has been completed. They will also continue right-of-way clearing in the Littlefork area. We would like to see the snow hold off for a little bit to get some frost in the ground; it helps make these tasks much easier.

Some of you may have heard about the infrastructure grants and funds available from the federal government. North Star is part of a coalition of 85 co-ops and municipals from Minnesota, North Dakota and Wisconsin who submitted their plans to the Department of Energy for consideration. Unfortunately our first proposal was denied, but there are a couple more rounds remaining so we will be reexamining our projects for another try. If successful, this will be a big help for the co-op, so I hope it works out. That's all for now, Tim

Members who use electricity as their primary source of residential heat are exempt from paying taxes on the electricity purchased during the billing months of November through April. If more than one type of heat is used, electricity is not taxable only if it is the primary source of heat for the largest period of time during the heating season (664-20-020-01, Robin Hoopman). 
INGREDIENTS
